"Living the Three Rules"

Listen carefully to these three quotes, two from Jesus and one from John Wesley:

"Hearing that Jesus had silenced the Sadducees, the Pharisees got together. One of them, an expert in the law, tested him with this question: "Teacher, which is the greatest commandment?" Jesus replied, 'Love the Lord your God with all your heart, and with all your soul and with all your mind.' This is the first and greatest commandment. And the second is like it: 'Love your neighbor as yourself.' All the Law and the Prophets hand on these two commandments."

## **Drive-In Worship!**

**Sunday, June 7, at 10:30 a.m.** we will gather in our UMC parking lot for a 45-minute worship service. Please plan to drive in, park, and remain the full time.

Drive-In worship service

- Parking attendants will guide you to a parking spot.
- No car swapping, please!
- No more than 10 people to a vehicle.
- You may listen to the service on your car radio on 90.5 FM or bring a lawn chair to sit outside (socially distanced, of course!).

- Our FM broadcaster will only reach our immediate parking area.
- If you want to sit in the back of your pick-up, that will work also!
- Access to the bathrooms will be very restricted.
- In case of bad weather, Drive-In Worship will NOT be held.
- We will continue to record online worship for you to access at any time.



Spearfish United Methodist Church is working with a three-phase Re-Entry Plan as a guide to returning to active life within the church. This plan is guided by John Wesley's "Three Simple Rules", which provides a message and a method of how to plan to care for our church through the COVID-19 pandemic. This is based on the Re-Entry Plan designed by the Iowa Conference of the United Methodist Church. Wesley's rules have been placed within a stoplight framework to guide us as we move from red to yellow to green status in an intentional and careful model of care and accountability.

Our Church Council as the governing body of our congregation, will review this plan in conjunction with the Worship Transition Team.

## Level 3: **Red Light Status** – This is the "Stay in love with God" phase of our ministry:

- Stop all non-critical meetings at the church.
- The church office is open with social distancing and reduced hours.
- Shift all church meetings to online formats such as Zoom, Messenger, and Facetime. This applies to committees, task forces, and studies.
- There will be no live worship with all worship being online.
- High risk individuals should practice social isolation.
- Preschools will not meet.
- Outside organizations will not use our facilities.

## Level 2: <u>Yellow Light Status</u> – This is the "Do good" phase:

• Cautionary return. There is no specific timeline. This means a gradual return to gatherings and doing so in a cautionary manner. Our Church Council holds the authority to decide timing with these standards. It shall be informed by the Worship Transition Team and the Covid Financial Task Force.

- Church meetings continue in online formats.
- The church office is open with social distancing and reduced hours.
- Worship will continue to be online AND a Drive-In Worship option will be offered.
- High risk individuals should practice social isolation.
- Preschools will prepare and communicate their reopening strategies with the church office. Children First and Co-op Preschool boards will determine their re-opening schedules.
- Outside organizations will begin to use our facilities with smaller groups and COVID-19 sanitizing procedures in place.

## Level 1: Green Light Status – This is the "Do no harm" phase:

- This happens because the virus is contained and our people are safe. This will happen as our church leadership is confident in the care of our congregation. We will be listening carefully to federal, state, city, and CDC recommendations.
- A visit from Monument Health advisors will be arranged in order to receive their recommendations for going forward with the use of our physical building and facilities.
- Church meetings may continue online but will be given the option to meet live.
- The church office is open with flexible hours.
- While online worship continues, we will begin to transition from Drive-In Worship to worship in our sanctuary. Social distancing, masks, sanitizing and CDC recommendations shall be followed. Alternatives to physical greeting (hugs and handshakes) will be proposed.
- High risk individuals should be very careful in which church activities they participate in.
- Preschools will resume with their COVID-19 strategies in place.
- Outside organizations will resume their meeting schedules with sanitization procedures in place.

## **Caring Meal Ministry**

When you hear of an illness, death in the family, or any other need for a meal please call the church office (642-3457).

The Caring Meals Ministry provided 14 meals in April. People are so appreciative of the meals and the

show of care and concern from our church. One of the recipients who received a meal said, "Isn't Christian love a wonderful thing? Thank you for these wonderful meals and the loving kindness. May God continue to bless you all."

Our church wants to reach out to people in time of need. It means so much to know that people care! We see many needs in our community and world during this time. We continue to pray for HOPE, PEACE, and HEALING!

## **Children First**









Things at Children First are still very quiet as we continue to be closed. The CF Board of Directors has voted unanimously for CF to remain closed through at least June 14, 2020. They will meet again in early June to discuss what to do for the remainder of June. COVID-19 operating policies and procedures have been created and approved by the board and shared with the church Council. These policies and procedures will be put into place whenever CF does open.

The week before Easter some of the Children First staff got together and created Easter baskets for the children. A group of staff members got together and delivered the baskets to all of the children. It was so fun to see the children and their reaction to their teacher coming to their house! We miss them all so much and look forward to the day when our building is full of children again!!



#### Council Highlights May 20, 2020

√ Treasurer's Report: A payment was made in April on the Parsonage/UMCOC Heating Upgrade loan, and the Balance Sheet was accordingly updated. New balance on the loan is \$174,345.06. At the very end of the Balance Sheet is the Payroll Protection Program (PPP) Loan. SUMC received \$101,500 as a government loan which will be forgiven if SUMC uses it for the right things – mainly payroll, health and pension benefits, utilities, and interest on any other loans. So far SUMC has used \$23,927.88 leaving a balance of \$77,572.12. For the month of April income for the General Fund is \$42,693.24 including money from the PPP loan in the amount of \$10,558.22, and expenses are \$42,990.73 due to a large snow removal bill and an insurance payment. So, thanks to the loan, the General Fund broke about even for April with an ending balance for the month of \$297.49 in the red with apportionments paid. The year to date balance is \$8,954.62 in the red. For April the income for **UMCOC** is \$5,663.85, including UMCOC's share of the PPP loan which is \$968.85, and expenses are \$7,928.72 because of the snow removal bill and an insurance payment. This leaves the UMCOC Fund in the red \$2,264.87 for the month and in the black \$1,057.83 for the year to date balance. Income for April for Children First is \$43,471.84 including \$12,455.81 from the PPP loan and also a gift of \$22,000 from a congregation member. Expenses are \$33,208.43 which included an insurance payment and payment of full rent to UMCOC. Children First ended the month in the black \$7,352.02. Year to date balance is \$36.475.31 in the black eight months into the CF fiscal year. The Debt Retirement/Capital Fund income for April is \$3,061.66. Expenses are \$7,000 reflecting a payment on the Parsonage/UMCOC Heating Upgrade loan. Year to date balance is \$50,313.80. Mission-giving for April is \$11,805.00, mostly due to a large contribution to Pastor's Discretionary. Mission expenses (distributions) were \$3,735.00. The Mission of the Month was the Food Pantry for which the offering was \$460.00. Scott commented that the church received a certificate of appreciation from the Solar Oven mission, because there were enough donations from our church so that each month a family could receive a solar oven in 2019.

Children First Report: During May, Children First will be reimbursing families who will not be returning to CF and giving credit to those who are returning. The reimbursement for the second half of the month of March is approximately \$3000 and the half month credit is approximately \$13,000. The plan is to use part of the large anonymous donation we received to cover these expenses. The expenses for CF have been much lower than normal due to being closed, except for a large bill from an attorney who helped with multiple staff questions and policy revisions. The decision about when CF will open again has not yet been made. If open during the summer months it will be a financial strain, as enrollment will likely be much lower due to concerns about COVID-19. Before opening, there will be expenses related to cleaning, purchasing snacks and needed classroom items. As of now, all of the employees have been maintained and CF

will be able to pay them full wages through at least the middle of June.

- ✓ Children, Youth & Family Ministries Report: Children's Church will continue in an online version throughout the summer. VBS is being pushed back to mid-August with best options being discussed. The thoughts right now are to have a two-day event.
- ✓ Health Ministry Report: 14 meals were delivered in April with the Caring Meal Ministry. Kathy Schneider and Linda Hoxie alternate months in coordinating this. Grief follow-up continues but booklets and a letter are mailed out now, instead of face to face visits. Phone contacts are also made. The Diabetic Screening and Health Forum, have been postponed. A Prayer Shawl Ministry will be started; it will be a small crocheted square with a cross in the middle and a saying. Bev Carr is helping with the crocheting. We continue to promote prayer. One of the most important things you can do is to wash your hands-OFTEN! A 20-second wash is recommended-keep a bottle of hand sanitizer in your vehicle.
- ✓ Staff Parish Report: We had a discussion about cleaning and maintenance of the boiler at UMCOC and possible adjustments to Barry's job description in that area. We are still planning for Barry's shoulder surgery and how to cover the work while he is recuperating. We had a brief discussion on what church service could look like in the future.
- ✓ Stewardship And Finance Report: Ron Borgman reported on renter contracts which have gone out. He composed a response to UMCOC renter requests with the following points: a seven-month agreement, June to December 2020; June through August would be at the full rate and continue unless governmental authorities prevent routine schooling; if schools are closed, the rates for September- December 2020 would be reduced to half rate; and internet service remains at \$25 per month. It was suggested that Ron add a requirement of a 45 days' notice if the Summit school was going to move to another building. It was determined that Church Council needs to decide about other groups using the church building and any policies that need to be in place. Melissa Raad and Sarah Hazledine are working through the policies and practices that should be in place in order to reopen Children First. Chris Davis asked if we could get a monthly report from NHSOS on their activities and other sources of funding, since the church currently has \$38,000 set aside in reserves until October 2021. Pastor Scott relayed that currently there is a housing shortage for lower income individuals and families, and NHSOS has been working on placing individuals. None of the NHSOS funding is given to individuals; it is used strictly to run the program. Scott will request that SOS provide a monthly update for the S & F meeting. Chris Davis reported on the CFTF group whose purpose/mission was to provide financial guidance to Spearfish United Methodist Church (SUMC), Children First (CF), and United Methodist Outreach Center (UMCO) in order to maintain financial solvency for each entity between, at a minimum, April through August. The team will suggest action plans whether to use reserves, pay wages, pay apportionments, etc. It is composed of individuals from S&F, Trustees, Children First and Council. The group looks at the big

picture and reports to Stewardship and Finance but does not have authority to act.

- ✓ Trustees Report: A different company was hired to do lawn care one time per week, perhaps moving to every 10 days later in the summer. Groups such as AA, NA, and Co-op Preschool are wishing to resume meetings and programs. A discussion of this subject was held with most feeling that groups outside the church should not be allowed to resume meeting since we are not using the church for our own services. Trustees want to prepare a process for using E-mail, on an emergency basis, to move on questions that come up. Mark Tracy was chosen as chairperson for the balance of the year, and John Swanson will serve as vice chair. We still need to appoint two new members to the Trustees.
- ✓ <u>UMCOC Report:</u> Three yearly tenant contracts were sent out and all have been returned, two that will remain the same, and one, Summit Church home school program, was revised. Trustees approved the revised version which was prepared and e-mailed to the Summit Church home school leader. During the new boiler installation, a comment was made that we need to try and get better natural gas pressure. Climate Controls is looking into that and what needs to happen. Trustees agreed to reduce CF room rates by half for the first half of June since they will try and open mid-June.
- ✓ <u>United Methodist Women Report</u>: The regular UMW summer schedule is very limited since they do not hold meetings June August. A planning meeting will be held in August. In the event that we can gather safely, there will be something put together for a face to face meeting.
- ✓ Worship Committee Report: Many thanks to Scott McKirdy, Colleen McKirdy, Emma McKirdy-Wilsey, Connie Hubbard, Michelle Jennings, Annette Bailey, Ellen Plocek, Chris Davis, Katrina Garnett, Heather Brewer, Kathy Helmer, Janelle Jones, Kevin Nakajima and others for preparing our online worship services this month. This has required planning and preparation and then the lengthy process of recording, editing and uploading the video to the church website. Members of the Worship Committee have met online to discuss ways to support Pastor McKirdy as he leads us in worship each week. More online resources are being developed to draw us together during this time of physical distancing. Pastor McKirdy has convened the Worship Transition Team to develop ways to move back into live, in-person worship services. This committee is moving carefully by studying good resources about ways that the COVID 19 virus spreads, the experiences and practices of other church communities, and the special needs that face our members.
- ✓ **Youth Council Report:** Youth continue to meet via Zoom, and Brenda continues to work at home. We are talking about in-person gatherings and what that would look like and when. Likely, it would be outdoors with social distancing in place. We are trying to come up with a creative way to honor our graduates. No plans yet for rummage sale, but Brenda is looking at fall for scheduling it. All summer mission trips and camps are on hold until next year.

*Discussion Items...*Melissa Raad, Director of Children First reported on the COVID 19 Policies and Procedures that she and Sara Hazeldine created using CDC guidelines for reopening

schools and daycares with "safety first" in mind. Tentatively, they are looking at opening again on June 15, but that will depend on how the community spread happens in this area. Currently, the building is empty with no children, but staff are being paid. The consensus of the Church Council was that the policy is well thought out and covers all aspects needed for the school to re-open. The policy document is available in the church office. One of the stipulations in the policy is that Children First will be inspected by a team from Monument Health prior to opening and again after it is up and running with children to ensure that all CDC guidelines and protocols are being followed. Ron Borgman is in the process of developing a similar policies and procedures requirement for all UMCOC tenants. Chris Davis gave an update from the Church Security Task Force. Outside updates include extra security lights, replacement door locks, and pass codes that are only accessible on certain doors and during certain hours. Those with pass keys sign a contract on access to the church and the importance of safety for all. Currently, they are looking to develop a medical team to volunteer to assist with things such as a heart attack and an observer team to actively look for persons of interest who might not be looking for a place to worship but rather have other motives. Connie as Council Chair would like to see a more streamlined reporting system for the committee reports and will work with Penny Louks to develop a template. The Worship Transition Team is planning Drive-In Worship, starting the first weekend in June. The FM system for the hearing aids/90.5 will work in a 200-foot radius so most all parking spots at the church will be able to access the signal. Kevin Nakajima is going to be developing a proposal for the 3 options for upgrading our video recording/sound system so that our online ministry can continue more professionally when face-to-face worship resumes.

Action Items...Trustees brought an action item about outside groups wanting to resume use of our church building, feeling that if the church isn't open that we should not allow others to use it. The groups specifically being referred are those who use the Fellowship Hall, kitchen, upstairs classroom, and the bathrooms. Additionally, Spearfish Co-op Preschool asked to use their downstairs space for summer school starting on June 6 and running through July. Much discussion was held concerning safety during COVID 19, referring back to the Children First policies often. Chris Davis made the following motion: No outside groups, excluding Spearfish Co-op Preschool, are allowed to use the church building until we are back to regular worship. Colleen McKirdy seconded it. The motion carried.

Next Meeting of the Council will be on June 17, 2020.

### **COVID Financial Task Force Update**

During this time of COVID 19 restrictions and economic impact, a COVID Financial Task Force (CFTF) has been formed to support our Finance Committee in making economic decisions for Spearfish United Methodist Church (SUMC) which consists of the church (UMC), Children First (CF), and United Methodist Community Outreach Center (UMCOC). These three entities were fortunate to receive a Payroll Protection Plan (PPP) loan of \$101,500 to cover payroll and utilities for the period April 20 through June 14.

As this task force reviews Income and Expenses, we notice that Expenses continue to exist while Income has decreased during the month of May, and projections about the future are hard to make. We do know that there will be two large expenses, one in the near future and one in the fall as our air handler system switches between the heating and cooling systems as the seasons change. Our Trustees have also had to hire a lawn care company to take care of our block. This cost is \$175/mowing and it is anticipated that mowing will need to be done on a weekly basis for an approximate cost of \$700 per month. If you would be interested in donating to lawn care, the money currently expensed for lawn care could be used for other uses and ministries of the church. This designation could be indicated in the Memo Line of your check

After June 14, the CFTF will do its best to not dip deeply into our reserve funds or make the decision to not pay certain commitments, such as apportionments which support the ministry of our conference and the greater church.

The above information is shared with you to let you know that while the work of the church continues, we will face some hardships and uncertainties. The CFTF appreciates the generosity that has been shown from the congregation and we ask for your continued financial support and prayer as we look forward and plan for the future.
